DCM Logic's BoilerSuite™ —BoilerScope™ and BoilerBrowser™ :

One of DCM Logic's products is the BoilerScope™, a hardware device designed to collect and transmit key parameters and operating data from up to four linked boilers. DCM Logic has also developed the BoilerBrowser™, a web-based interface to allow users to view, log, and analyze data collected by the BoilerScope™. BoilerSuite™ enables boiler owners, installers and maintenance providers to check on the operation of their equipment and analyze its performance from anywhere.

Our BoilerSuite™ also helps installers to eliminate unnecessary trips, quickly identify when a visit is needed, and provide the information required to make the visit as efficient as possible. By using the BoilerSuite™, installers can easily troubleshoot boiler operation issues remotely with manufacturers and distributors of boiler equipment quickly and on a real-time basis instead of waiting for their on-site assistance.

DCM Logic keeps this data to benchmark boiler performance, suggest operational adjustments, and flag opportunities for cleaning and maintenance. The BoilerSuite™ currently performs a monitoring role only and cannot be used to adjust boiler parameters remotely.

Owner hereby grants Installer the right to install, and, if necessary, maintain, repair and replace, on its own or with the assistance of other parties, the BoilerScope™ boiler monitor at its Address to collect and transmit boiler performance data. Installer has or will soon enter into a non-exclusive licensing agreement with DCM Logic LLC, the manufacturer of the BoilerScope™ and developer of BoilerBrowser™, to monitor, view, log and analyze data collected and transmitted by the BoilerScope™.

Owner hereby grants Installer the right to monitor, view, log and analyze data from its boilers using BoilerBrowser™. Installer may also grant permission to related parties (Related Parties) such as boiler manufacturer, boiler importer, boiler distributor/reseller, and relevant HVAC professionals to access data from Owner's boiler(s) via BoilerBrowser™ for limited periods of time for the sole purpose of improving the functioning of the boiler(s).

Owner also grants Installer the right to photograph the monitored boilers and grants Installer and DCM Logic LLC the right to display such images to Related Parties. DCM Logic LLC may also display such images to others, provided information identifying the particular installation is not divulged.

Owner grants to DCM Logic LLC the right in perpetuity to view, use, store, share and license data collected from its boilers with the exception of information identifying the location where the data was collected. All data and site information may be shared with and licensed to Installer and Related Parties.

Owner understands that BoilerScope™ and BoilerBrowser™ merely aid in monitoring the operation of the boilers and shall not hold DCM Logic LLC responsible for ensuring the successful operation or a certain level of performance of the boilers, even in the event that the BoilerScope™ and/or BoilerBrowser™ malfunction or their function is interrupted.
